CSIRO Publisher

In late 2015 Chris Anderson resigned from CSIRO and Brietta Pike has now filled this role.

Promotion and profiling of the Journal

The promotion and profiling of *HPJA* is ongoing as we aim to increase new submissions. The Editorial team have discussed promotional opportunities with CSIRO and have been active in promoting the Journal by:

Submission of manuscripts to the Journal

New submissions to the journal increased by 20% in 2015 (see Table 1). As stated previously, the required quality of accepted manuscripts can be lowered by accepting 'lesser papers', but the preferred approach would be to increase the number of submissions of higher quality submissions, so that quality can be maintained and even increased. Currently the acceptance rate is about 47.5% (57 papers) resulting in approximately half of those manuscripts that are submitted, being accepted. This achieves the target of 50 papers annually.
