

Editors' Report 2018 Professor James Smith – Editor in Chief

Overview

This report presents an overview of key achievements associated with the Health Promotion Journal of Australia (HPJA) from January 1 to December 31 2018.

Impact Factor 2017

The 2017 Impact Factor (1.125) was released in June 2018. This figure represents the number of citations in 2017 in relation to content published in the journal in 2015 and 2016, divided by the total number of citable items published in a two year period. This represents an increase from the 2016 Impact Factor, maintaining HPJA's reputation as a highly reputable national and global leader in the publication of contemporary peer-reviewed health promotion scholarship.

New Editorial Team

2018 marked the commencement of a new Editorial Team. This included the establishment of an Editorial Executive Team comprising:

Publisher

In 2018, Wiley commenced as the new publisher of HPJA. This meant the HPJA was transitioning the Editorial Team and the publisher at the same time. While there were a few minor logistical issues encountered, the transition was smooth and the journal continues to flourish. The HPJA Editorial Team would like to acknowledge and thank the Wiley team for its collaborative approach. In particular, we would like to thank Peter D'Onghia, Alison Bell, Christelle Ronquillo, Martha Rundell and Marjorie Ang for their hard work and responsive nature.



Journal Scope

An initial task of the new Editorial Team was to revise the scope of the journal. There was a strong sentiment among all Editorial Team members that a more explicit focus on the social and ecological determinants of health was required, with a heightened focus on promoting health equity. The revised journal scope now reflects:

The Health Promotion Journal of Australia is a peer-reviewed journal that publishes high-quality research and critical perspectives from researchers, decision-makers, and practitioners that contribute to improving knowledge and evidence for health promotion action across Australasia. We also welcome international contributions of relevance to the region. The journal welcomes submissions about educational, cultural, organisational, economic and/or environmental approaches that address health promotion issues, advance the health promotion profession; and which support positive system changes that benefit population health. Manuscripts that address social and ecological determinants of health and/or issues relating to the promotion of health equity are strongly encouraged. Preference is given to articles presenting significant, innovative, and/or useful findings from methodologically robust and cutting-edge qualitative and quantitative studies of health promoting policies, strategies, programs and evaluations.

Manuscript Categories

Another task of the incoming Editorial Team was to review the manuscript categories. This resulted in the inclusion of three new categories in 2018:

- Long research articles (4,500-6,000 words) to better accommodate high quality, theoretically rigorous and methodologically robust qualitative and mixed-methods papers;
- Reviews (2,500-4,000 words), including scoping reviews, systematic reviews, narrative reviews, critical reviews, realist reviews and meta-analyses; and
- New types of book reviews (up to 2,000 words) expanded to include ordinary reviews, vintage book reviews, and book review essays.

The Editorial Team envisages this will generate new and informative content for the HPJA readership.

Journal Reviewers

The new Editorial Team has also worked solidly to expand the reviewer database throughout 2018, with early indications demonstrating a doubling in reviewer numbers. We thank all reviewers who willingly volunteer their time to maintain the high quality of the HPJA. We also thank the AHPA Board for supporting a reviewer networking and acknowledgement event during the National Health Promotion Symposium in Canberra.

Shift in Publishing Schedule

Throughout 2018, the Editorial Team has been working with the REET Committee, to shift the publishing schedule from April, August and December in 2018 to January, April and August in 2019 and beyond. This meant there was considerable effort in preparing the December 2018 issue in quick succession with the January 2019 issue. This process was implemented successfully as planned. This shift in publishing schedule increases the potential for articles to be read, and subsequently cited, in any given year. In turn, this influences the Impact Factor of HPJA.

Strategic Directions

Throughout the first eight months of 2018, the Editorial Team meet on a bimonthly basis to develop a strategic plan for the HPJA. This was reviewed collaboratively with the Wiley publishing team and the REET Committee at a face-to-face to meeting during the National Health Promotion Symposium in Canberra. This provides a clear road-map for the direction of the journal for the next four years. Ongoing conversations about thematic, special and virtual issues of HPJA will continue throughout 2019. The Editor-in-Chief was supported by AHPA to attend the Wiley Editor's Meeting in Melbourne in November 2018. This provided an important opportunity to network with other journal editors and to stay abreast of recent peer-reviewed publishing trends, challenges and opportunities.



Capacity Building

A key strategy of the journal is to continue building the capacity of the health promotion community to write and review for publication. The Editorial Team ran a workshop at the National Health Promotion Symposium in Canberra in August 2018.

Supplementary Issue

In July 2018, a supplementary issue of HPJA was released (*Volume 29 Issue S1*), comprising commentaries by invited national and international policymakers, researchers and practitioners on the topic "How would you spend \$100 million a year on preventive health?" This special supplement was guest edited by Associate Professor Jonine Jancey with financial support from The Australian Prevention Partnership Centre and the Foundation for Alcohol Research and Education. Thematic Issue

The August issue was published as a thematic issue. The focus was Injury in Health Promotion and was guest edited by Associate Professor Richard Franklin (James Cook University) and Dr David Sleet (U.S. Centre for Disease Control) with the support of Associate Professor Jonine Jancey as outgoing Editor-in-Chief.
