Eligibility

All applicants must:

- Be a financial, individual, full category (\$220/year) member for a minimum of 2 years prior to closing date.
- Have actively contributed to AHPA through activities at a local or national level.

- Be available to participate in the course in full.
- Submit a short article with 1-2 photos for publication in the AHPA e-news (100-150 words, within two weeks of participating in the activity). The article may include: *the most valuable lessons learnt; how learnings will be applied to health promotion practice and the development of health promotion competencies; how learnings contribute to AHPA's vision and purpose; how the recipient will disseminate and apply their learnings including through AHPA.*
- Agree to participate in social media activity and/or assist with any AHPA activities or promotion leading up to, during or after participation in the professional development (as appropriate)
- Agree to lead at least one national advocacy activity for AHPA over the next 12 months.

Assessment of applications

- A panel will assess all applications received by the closing date according to the purpose and criteria.
- Applications received after the closing date will not be considered.
- If no applications are suitable, the place will not be awarded.
- The panel's decision is final.
- Successful applicant(s) will be notified of the outcome of their application shortly after the closing date.
