About AHPA

The Australian Health Promotion
Association (AHPA) is Australia's peak
health promotion body in Australia and
is the only professional association in
Australia specifically for people
interested or involved in the practice,
research and study of health promotion.

The Association has operational branches in most states and territories with more than 1000 members and subscribers, from government departments and agencies, universities, non-government organisations, community-based organisations and groups, private companies and industries, and students. As an Australian Public Company limited by guarantee, the Association must meet the requirements of both the Corporations Act 2001 and its own Constitution. These two documents together form the framework within which the Board of Directors governs the company.

The national work of the Association is conducted through a number of committees and working groups. For 2013 these were the:

At the national level current activities include:

- the National Conference usually held annually and hosted by Branches;
- a collaborative tri-yearly Population
 Health Congress with partners: Public
 Health Association of Australia, the
 Australasian Epidemiological Association
 and the Australasian Faculty of Public
 Health Medicine;
- the Health Promotion Journal of Australia;
- the Australian Health Promotion Update;
- the website providing professional and membership information; &
- the national listserv providing members with employment, advocacy and events information.

At the branch level activities include:

- professional development, such as seminars, workshops and training;
- employment scholarships for health promotion students or graduates;
- mentoring programs;
- conference scholarships;
- jobs and events e-lists; and
- newsletters outlining current activities and local issues; and advocacy activities.

To Members & Supporters

Welcome to the 2013 Australian Health Promotion Association Annual Report.

It was another very busy year of consolidation and progress in governance, internal operational systems, and in the priority areas documented in AHPA's Strategic Directions. We progressed our professionalisation agenda, focused our advocacy efforts around the federal election, continued to work to build our partnerships and strategic alliances, streamlined processes around the journal to increase its profile and reputation, delivered the 2013 conference and progressed planning of the 2014 conference.

It was also a year of transition with a number of new Board members elected and handover of roles. We welcomed Michele Herriot as our new Vice-President, and Paul Klarenaar and Justine Leavy as incoming Board members at our AGM in June where we also farewelled outgoing Board member Emily Raso. Antoine de Saint-Exupéry, the author of *The Little Prince* once noted that "If you want to build a ship, don't drum up people to collect wood and don't assign them tasks and work, but rather teach them to long for the endless immensity of the sea." This quote reminds me of the achievements that can be made through a sense of shared purpose and the importance of a long term vision for a well-functioning national professional association. I would like to thank **Suzanne Gleeson** and **James Smith** for their guidance and mentorship and acknowledge them as AHPA's newest **Fellows**, well-deserved honours for their able stewardship of AHPA over the past few years.

We continued our relationship with Not-for-Profit Accounting Specialists (NFPAS) to provide AHPA's secretariat, book keeping and accounting services. NFPAS worked with AHPA's contractors, Lyndell Llotz and Veronica Kypros, to determine what needed to be in place to meet AHPA's needs at both the national and branch levels. Contracts for Lyndell and Veronica finished on the 31 July 2013 and the Board thanks them for the excellent service they provided to AHPA. NFPAS has reviewed the setup of MYOB including the chart of accounts, job costing and budgeting and will review the flow of the current processes. NFPAS has also undertaken an accounting review of current policies, forms, templates, procedures and end of the month review. The Board continued with this model to use AHPA's limited resources effectively and efficiently. The resolution at the 2012 AGM to engage Simon Fry Chartered Accountant, SA as AHPA's auditors for 2013 was implemented.

To take the Association forward, the Directors met for two 2-day, face to face Board meetings (in Melbourne in May and in Adelaide in November). The Board covered a very full agenda taking forward the strategic planning process, the professionalisation of health promotion project, annual conference and professional development agenda, the budget, advocacy structure, infrastructure, and strategic partnerships. Other items included the website, constitutional review, ways to reduce operational responsibilities of Branches and the Board.

In addition to progress relating to governance, and internal operational changes, much has been achieved both at the National and the Branch. All these initiatives continue to build the foundations for a financially successful and sustainable future for the Association and by implication, all members.

- 10. Scoping the best way to deliver advocacy, and delivering on our plans; and

Advocacy

Advocacy is one of the key pillars of AHPA's Strategic Plan, and remains a primary commitment of AHPA, nationally and at branch level. During 2013 a decision was made to change the way advocacy is done at the National level. For many years there was an Advocacy Committee which led national advocacy work, but this committee was put on hold in August whilst the Board determined the most effective mechanism for the Association's advocacy efforts. The lack of formal committee didn't deter advocacy efforts in 2013 with a range of activities undertaken. AHPA has committed to advocacy around the Social Determinants of Health and so has focussed efforts and resources on its contribution as a founding member to the SDOHA.

Members of the Board's Advocacy Committee facilitated a workshop at AHPA's 21st National Conference, *Hear our Voice – What should we tell our politicians before the 2013 federal election?*, in part to identify priorities that members and other Conference participants could use to form the basis for advocacy activities prior to the Federal Election in September 2013. From this workshop an infographic "Invest in Health Promotion" was developed prior to the federal election, highlighting the significant return on investment that health promotion generates. The infographic was well received and gained broad coverage in health media including Croakey. A 'post-election' version was adapted as a resource to advocate for ongoing investment in health promotion.

Additionally, the Association supported a range of advocacy efforts around the Trans Pacific Partnership Agreement, withdrawal of funding of the Alcohol and other Drugs Council of Australia (ADCA) and the Review of Medicare Locals. Thanks to all those who contributed to national advocacy efforts in 2013.

Strategic Planning

The Board established a time limited Strategic Planning Working Group in 2012 to prepare the next strategic directions plan to guide the work of the Association over the next 5 years.

The Group continued the process of developing AHPA's Strategic Plan to guide priorities over the next five years. In last year's Report http://www.healthpromotion.org.au/about-us/constitution-and-annual-reports you will find the consultation process and progress.

Over the next few years AHPA's work will focus on:

- 1. a sustainable well informed Health Promotion workforce;
- 2. advocacy for health promotion priorities; and
- 3. a strong, responsible and responsive professional organisation.

AHPA's Board will continue to build on past efforts and work in concert with Branches to achieve significant outcomes within each of these priority areas, both for the advancement of the profession and the health of all Australians. The Strategic Plan will be posted on AHPA's website mid June 2014.

Finance, Audit and Risk Management

2013 was a year of change for finances in the organisation. Engaging the services of Not for Profit Accounting Services (NFPAS) has streamlined and centralised the accounting systems of the organisation, developed a uniform payment and invoicing process and expedited the completion of the Annual Audit.

Most notably, the adoption of services from NFPAS has meant volunteers can focus on growing the profession and organisation rather than administrative financial processes of payments, BAS statements and audit preparation.

Consequently, and with significant guidance from NFPAS, AHPA now has a consolidated annual budget across the organisation, a network of branch and national treasurers, and a manual of consistent financial and asset management procedures. Work in the coming twelve months will need to focus on adoption of processes and growing the organisation's competence in risk management.

Professional Development

2013 Conference

In 2013, the NSW Branch hosted the national AHPA health promotion conference in Sydney in June which was held at the picturesque Darling Harbour. The event was a great success with more than 460 delegates participating in the event to hear keynote speakers such as Professor Mark Dooris and Professor Helen Roberts and Associate Professor Marilyn Wise (who delivered the Eberhard Wenzel Oration) cover topics from healthy settings to the creating and maintaining child health and health inequities for indigenous Australians.

As always, planning a successful conference requires a huge amount of time, energy and sweat and so we would like to acknowledge the hard work of the NSW Branch Committee members and all our volunteers and supporters for their generous efforts in planning, and delivering the conference. Special thanks to conference co-convenors Karen Bedford and Suzanne Gleeson, and Prof Chris Rissel, Chair of the Scientific Committee, for their skill and expertise given to the planning and implementation of the conference. 2014 Conference

In 2013, conference planning began in earnest for the 2014 conference. For the first time, AHPA will partner with the Northern Territory Chronic Diseases Network (CDN) and the Northern Territory Medicare Local (NTML) to deliver the 22nd AHPA National Conference and the 18th Annual CDN Conference in Alice Springs on the 4-5th September 2014. Throughout the year conference themes, speakers and venue were secured as well as the conference organising committee. The theme of the conference is Equity @ the Centre: Action on Social Determinants of Health. The focus on equity is to demonstrate the centrality of fairness and social justice as the underpinning principles of contemporary health promotion, prevention and comprehensive primary health care activities and system reforms across Australia. The focus on social determinants of health responds to the growing national and global evidence and commentary acknowledging the need for action.

2015 Population Health Congress

Planning is underway for the 3rd Population Health Congress which once again sees collaboration with Public Health Association of Australia, the Australasian Epidemiological Association and the Australasian Faculty of Public Health Medicine. The Congress is slated to be held in Hobart with a theme of One Vision, Many Voices. Initial meetings have been held with a site visit proposed for early 2014.

Research, Evaluation and Evidence Translation

Throughout 2013, the *Health Promotion Journal of Australia* Committee transitioned into a broader Research, Evaluation and Evidence Translation Committee. Committee members included Dr James Smith (Chair), Dr Jenni Judd, Dr Justine Leavy, Professor Chris Rissel and Dr Jonine Jancey. After transitioning the administrative functions of publishing the *Health Promotion Journal of Australia* to CSIRO in late 2012, the CSIRO commenced publishing all three issues of the *Health Promotion Journal of Australia* in 2013, with a significantly improved online presence, including early online publication of articles. The journal's impact factor rose from 0.592 to 0.800 during this period.

The *Health Promotion Journal of Australia* Editorial Team includes Dr Jonine Jancey, Professor Peter Howat and Professor Colin Binns (Curtin University) and Associate Professor Stacey Carter (University of Sydney). The Editorial Advisory Board has been expanded and there are plans to appoint an Editorial Assistant in 2014. The Ray James Award for excellence and innovation in health promotion research published in the *Health Promotion Journal of Australia* was presented to Dr Jude Comfort and Kahlia McCausland at the 21st National Health Promotion Conference in Sydney.

Aboriginal and Torres Strait Islander Committee

In 2013 as part of succession planning for the Committee, we saw the role of the chair transition from Dr Jenni Judd to Pele Bennet who is the Committee's first Torres Strait Islander Chair. Members of the committee were: Summer Finlay (NSW) (minutes & meeting organisation), Antoinette House (ACT), Jo Warneck (Vic), Luita Casey (SA), Margaret Cargo (SA), Norah Ansey(NSW), Lisa Rooke (WA), and Patrice Harald (Qld).

Over the past few years this committee has made one of its priorities to support the local branches that are organising the National Conference to facilitate in partnership a preconference workshop. Some of the committee members have participated in the NT conference Aboriginal and Torres Strait Islander reference group for the Aboriginal and Torres Strait Islander pre-conference workshop. As a result of this participation there should be another strong preconference workshop in Alice in September 2014.

The committee continues to meet bi monthly, as a result of the additional committee meetings that are being attended by members for input into the National Conference. The committee is also working to increase the number of Aboriginal and Torres Strait Islander members. Thanks to members of the Committee for their hard work and input to the work of the Association.



Partnerships and Alliances

Additionally we work closely with a range of organisations at a state and national level to deliver professional development and advocacy activities. In particular we work with the Public Health Association of Australia, the Australasian Epidemiological Association and the Australasian Faculty of Public Health Medicine to deliver the Population Health Congress.

Communication

Good communication is one of the core enablers for AHPA to achieve its purpose and vision

Significant work has been conducted to upgrade our website and list serv facilities, enhancing our ability to communicate with members and the broader community.

During the year AHPA joined Twitter - AHPA_AU. AHPA intends to develop this facility to communicate with members and share AHPA's position on important and emerging issues.

The Group will comprise members from SA, Queensland, WA, Tasmania and NSW and will be chaired by the AHPA Vice-President.

The first meeting will be held in 2014 and initial priorities will include additional updates to the AHPA website, communication including email and use of social media.



Professionalising Health Promotion Project

In 2011 AHPA initiated the Professionalising Health Promotion Project to explore the implementation of a regulatory model for the health promotion workforce.

The following is a summary of the project activities:

- 2011 Funding secured from Queensland Health and SA Health to evaluate benefits of introducing a certification or accreditation process.
- June 2011 Sadgrove Consulting was engaged to support the project and achieve key deliverables.
- October 2011 A scan was undertaken of national and international literature
- April 2012 A national stakeholder consultation was completed
- August 2012 A discussion paper was published (**Deliverable 1**)
- March 2013 National consultation on the discussion paper was completed (Deliverable 2)
- October 2013 Operational analysis and feasibility study on the implementation of a certification program for the health promotion workforce was completed (**Deliverable 3**)

Summary of Project Deliverable 1 - Discussion Paper

In August 2012 a discussion paper was released titled: 'Creating a Sustainable Health Promotion Workforce'. The paper:

- outlined the regulatory and non-regulatory options available to AHPA
- summarised the outcomes of a literature scan
- reconciled the recent regulatory reforms in Australia
- conducted interviews of key stakeholders
- developed a project plan, and
- made recommendations for a way forward.

The paper found that the best option for AHPA would be a combination of four strategies:

- 1) The introduction of a certification program designed to be inclusive and relevant to the broader health promotion workforce.
- 2) To pursue the inclusion of Certified Health Promotion Officers in the list of 'Common Health Professions' in the Health Professionals and Support Services Award 2010, and then ensure this takes effect in all related state awards.
- 3) The introduction of a continuing professional development (CPD) requirement to maintain currency of knowledge against key criteria.
- 4) The targeting of a number of key economic incentives that have the potential to significantly enhance the sustainability of the health promotion workforce.

Summary of Project Deliverable 2 - Consultation Phase

Following the release of the Discussion paper, a national consultation was undertaken to provide an update on the project's progress to members and communicate and clarify the implications of the Discussion Paper.

Summary of Project Deliverable 3

In 2013 the following documents were produced to inform decisions by the AHPA Board in regards to establishing the proposed health promotion certification program:

- Implementation strategy / Operational analysis
- Macro-environmental analysis
- Market analysis
- Competitor and brand analysis
- Financial analysis.

The operational analysis found that it may be feasible to establish a health promotion certification program from an operational perspective if AHPA can address a range of governance, resource, and policy issues.

New Directions


This formed the basis for a revamp of the branch and an approach to business in 2014 which is currently culminating in a governance review and new strategic direction.

2013 Annual General Meeting

Treasurer's Report

I'm pleased to be able to offer my report on the finances of the Australian Health Promotion Association (AHPA) for the 2013 year.

2013 has been a transformative year for the finances of the association with the engagement of professional accounting and bookkeeping services, updated centralised financial processes and the appointment of a new auditor aligned with the transfer of the association's books to South Australia.

The association remains financially viable with more than \$100,000.00 cash on hand in the National Operating Account \$50,712.14 in the National Interest Account and a Term Deposit nearing maturity with \$81,048.50 invested. As at the end of April 2014, the association had \$631,534.65 net assets across the whole association which is an increase from 2012.

The association made a profit of \$68,055.00 in 2013, significantly smaller than the \$301,366.00 profit of 2012. This is largely due to significant reductions of revenue to the association in the 2013 period. The changes in income are due to a smaller total of grants received by the association nationally in 2013, and smaller revenue for scholarship programs. There was also a \$20,000.00 reduction in membership income in 2013. This trend was noted by the board through regular financial reporting. Investigation found that total numbers in members are not changing markedly but we do have increasing numbers of 'student/unemployed' memberships which is indicative of the recent dismantling of the preventative health workforce in many States and Territories.

AHPA received significantly less copyright income in 2013 to the previous year, but the figure of \$17,000.00 in 2013 is a realistic figure moving forward. The copyright income of 2012, while claimed in 2012, related in some part to income from previous years.

The significant changes in expenses in 2013 were in the Accounting, Administration and Bookkeeping and Auditors remuneration. AHPA contracted to Not for Profit Accounting Specialists to provide Secretariat, Bookkeeping and Accounting services to the Association. While 2013 figures were \$9,000.00 greater than the previous year, the quality of service and reduced impact on volunteers across the association is significant. The 2012 Audit was extensive and drawn out and cost the organisation more than \$23,000.00 - \$14,750.00 more than audit fees retained.

Engaging the services of Not for Profit Accounting Services (NFPAS) has streamlined and centralised the accounting systems of the organisation, developed a uniform payment and invoicing process and expedited the completion of the Annual Audit. Most notably, the adoption of NFPAS's services has meant volunteer members can focus on growing the profession and organisation rather than administrative financial processes.

Consequently, and with significant guidance from NFPAS, AHPA now has a consolidated annual budget across the organisation, a network of branch and national treasurers, and we are close to finalising a manual of consistent financial and asset management procedures. The Finance Audit and Risk Management Committee have remained a great assistance to me in my role and I would like to take this chance to thank Gemma Crawford, Letty M'Kumbuzi, Suzanne Gleeson, David Duncan and Jenny Phillip-Harbutt.

Development of a national consolidated budget for the association has been a new and valuable process, but it has identified that the board is predicting a loss of up to \$60,000.00 in 2014, I would qualify this estimate by saying that this is the first time we have completed a full, nationwide budget and that it is very conservative in nature. The Budget also does not rely on income which the association cannot guarantee, like income received from copyright. The loss may be reduced through a change in the way that the journal is funded through CSIRO, which will be explored over the coming months. This could also affect the final position. It is still unlikely that AHPA will make a profit in 2014 though and if it does, it will be small.

Overall however, as previously mentioned, the association remains financially viable as we move in to 2014.

This is my final term on the Board as a Director and consequently as Treasurer. I have valued the opportunity and lessons of this role and I'm proud to leave AHPA's books, financial processes and financial position in a healthier state to when I took them on. I will remain in a caretaker capacity until the new Treasurer is appointed at the first board meeting of the new term.

I'd like to thank my colleagues on the Board, the Branch Treasurers and the organisation's contractors especially Not for Profit Accounting Specialists and Lyndell Lotz for their hard work and determination, often behind the scenes to keep the organisation functioning.

I welcome the opportunity to take questions.
